2017 LEAD FACT SHEET

PURPOSE: The purpose of the ARPA LEAD Program is to train potential leaders and **enhance** current leaders in the recreation field. This training is provided with the intention that it will assist the selected candidates in the development of skills that will make them effective leaders within their agencies, their communities, the profession, and ultimately ARPA.

ELIGIBILITY: Selected attendees must be current ARPA Professional Members in good standing with the Association. It is preferred that applicants have been a member of ARPA for at least 6 months.

NOMINATIONS: Any member of ARPA may nominate a candidate for ARPA LEAD. It is also acceptable for individuals to nominate themselves. All applications must include the signature of the nominee's/applicant's agency supervisor. Nominations will be reviewed by the Professional Development Committee. The program attendance will be limited and based upon review of application.

PROGRAM CONTENT: The 2.5 day program will consist of: Leadership development/enhancement activities, the history of ARPA, it's structure and how to promote ARPA and recreation, FISH! Philosophy and team building exercises. The program will also focus on potential opportunities for involvement by the attendees in ARPA and networking with fellow professionals. As a part of the program, outdoor adventure programming will be used which will require physical activity and participation. Classroom lecture, participation and other outdoor activities are also used. All adventure programming is challenge by choice

PROGRAM DATES: November 7-9, 2017, location Camp Skyline, Mentone, AL.

APPLICATION PROCESS: The LEAD application needs to be filled out completely and must include the signature of the applicant's supervisor.
