RULE XII– YOUTH FLAG FOOTBALL

ARTICLE I - ELIGIBILITY

SECTION A - AGE DIVISIONS

- (1) The age control date is on or before August 1st.
- (2) Divisions-
 - A. 8 and Under
 - B. 10 and Under
 - C. 12 and under
 - D. 14 and under
- (3) Teams must consist of at least five players with a maximum of 10 players.
- (4) Teams must start games with a minimum of five players. In the event of an injury, a team with insufficient substitute players may play with four players on the field but no fewer than four
- (5) A participant is allowed to compete in one age division only. Participants may compete in an older age division provided they remain in that same age division for all games and through all levels of NFL Flag competition.

- (6) A participant may compete in the District and state level provided he or she is not in violation of any rules or regulations in this Manual.
(REF: RULE 1)

SECTION B - ENTRIES

- (1) At the District level, an affiliate may enter as many teams as it wishes in all divisions provided the District does not establish an entry limit.
- (2) A District not conducting a District level tournament or playoff may allow one affiliate team to represent its District at the State level of competition.
- (3) Only persons whose names are approved on their affiliate team's ARPA Official Roster, who meet all ARPA eligibility requirements, and who are representing an affiliate not on current suspension from **NFL Flag** may compete in ARPA games.
- (4) The ARPA Official Roster limits are **10**.
- (5) State Tournament entries for each age group shall consist of up to nine teams, one representative from each District and a host Affiliate. If the entries fall below eight teams, the State Recreational Sports Committee Chairperson may add teams from other cities participating in their district tournament to insure an eight team bracket. A non-first place team's acceptance will be prioritized by their finish in their district tournament.

ARTICLE II - REGULATIONS

SECTION A - GOVERNING RULES

- (1) **The current rules are NFL Flag Rules.**

SECTION B – GENERAL RULES

- (1) **GAME**
 - a. **At the start of each game, captains from both teams meet at midfield for the coin toss to determine who starts with the ball. The visiting team calls the toss.**
 - b. **The winner of the coin toss has the choice of offense or defense. The loser of the coin toss has the choice of direction. Possession changes to start the second half to the team that started the game on defense.**
 - c. **The offensive team takes possession of the ball at its 5-yard line and has four (4) downs to cross midfield. Once a team crosses midfield, it has three (3) downs to score a touchdown.**
 - d. **If the offense fails to score, after crossing midfield, the ball changes possession and the new offensive team starts its drive on its own 5-yard line.**
 - e. **If the offensive team fails to cross midfield, on 3 downs, and elect to "punt" on 4th down, possession of the ball changes and the opposition starts its drive from its own 5-yard line. If the offensive team goes for it on 4th down and does not cross field, the opposing team will start its possession from the spot.**
 - f. **Teams change sides after the first half. Possession changes to the team that started the game on defense.**

ARTICLE III - EQUIPMENT

SECTION A - APPROVED EQUIPMENT

- (1) **The approved football**
 - A. **8 and Under – Blue NFL Flag Ball (Pee wee size)**
 - B. **10 and Under – Brown NFL Flag Ball (Junior size)**
 - C. **12 & under – Brown NFL Flag Ball (Junior size)**
 - D. **14 & under- Brown NFL Flag Ball (Junior size)**

SECTION B - UNIFORM REQUIREMENTS

- (1) **Participants must bring their own official NFL FLAG belts and mouth guards to the tournament.**
- (2) **All players must wear official NFL FLAG belts and mouth guards at all times while on the playing fields.**

- (3) NFL FLAG footballs will be provided. Team footballs are not allowed.
- (4) Players must wear shoes. Cleats may not be allowed at certain locations. This will be specified in the tournament details you receive prior to the tournament. However, cleats with exposed metal are never allowed and must be removed.
- (5) Players may tape their forearms, hands and fingers. Players may wear gloves, elbow pads and knee pads. Braces with exposed metals are not allowed.
- (6) Players must remove all jewelry, hats and do-rags. Winter beanies are allowed.
- (7) Players' jerseys must be tucked into shorts or pants if they hang below the belt line.
- (8) We recommend players wear shorts or pants that do not have pockets. Shorts or pants with belt loops or pockets must be taped. Games will not be delayed for a player to tape up pockets.
 - a. Flag belts cannot be the same color as shorts or pants.

SECTION C - FIELD DIMENSIONS

- (1) The field dimensions are 30 yards by 50 yards with two 10-yard end zones, and a midfield line-to-gain. No-run zones precede each line-to gain by 5 yards. However, some tournaments may use smaller fields because of field space available or to complete tournament scheduling on time.
- (2) No-run zones are in place to prevent teams from conducting power run plays. While in the no-run zones (a 5-yard imaginary zone before midfield and before the end zone), teams cannot run the ball in any fashion. All plays must be pass plays, even with a handoff.
- (3) Stepping on the boundary line is considered out of bounds.
- (4) Each offensive team approaches only TWO no-run zones in each drive (one zone 5 yards from midfield to gain the first down, and one zone 5 yards from the goal line to score a TD).

ARTICLE IV - GAME

SECTION A- TIMING AND OVERTIME

- (1) Games are played on a 40 minute continuous clock with two 20 minute halves unless one team gains a 28-point advantage, which will then end the game. Clock stops only for timeouts or injuries.
- (2) Halftime is one minute.
- (3) Each time the ball is spotted, a team has 25 seconds to snap the ball. Teams will receive one warning before a delay-of-game penalty is enforced.
- (4) Each team has three 30-second timeouts per game.
- (5) Officials can stop the clock at their discretion.
- (6) In the event of an injury, the clock will stop then restart when the injured player is removed from the field of play.
- (7) If the score is tied at the end of 40 minutes, an overtime period will be used to determine a winner.

Overtime format is as follows:

- (a) A coin flip will determine the team that chooses to be on offense or defense first.
 - (1) If a second round of overtime must be played, the team that lost the coin toss will get to choose offense or defense for the start of the second round of overtime. This process continues with teams alternating who gets to choose to be on offense or defense to start out during every round of overtime.
 - (2) The referee will determine which end of the field the overtime will take place on.
- (b) Each team will take turns getting one (1) play from the defense's 5-yard line for one point or the defense's 10-yard line for two points. Whether to go for one or two points is up to the offensive team. Whether or not the team that begins on offense converts the team that started on defense gets a chance on offense to win or tie by converting a one- or two-point play of their own.
 - (1) **Example:** Team A starts on offense and chooses to go for one point from the 5-yard line and is successful. Team B is then on offense and can choose to either go for one point from the 5-yard line to tie and force a second round of overtime or to go for two points from the 10-yard line for the win.
 - (2) If the second team on offense in an overtime round fails to beat or match the team that went first, the team that went first wins.
- (c) Both teams must "go for two" from the 10-yard line starting with the second round of overtime.
- (d) Starting with the 3rd overtime, each team will get 1 play from the 5-yard line going out from the endzone. The team with the most yards will be the winner. The team with the most yards will be awarded 1 point added to their final score.
- (e) All regulation period rules and penalties are in effect.

- (f) There are no timeouts.
- (g) Interceptions are returnable in OT, and worth 2 points.
 - (1) Both teams must have an offensive possession in OT. (Example-If first possession results in Interception that is returned, they must still take an Offensive Possession.)

ARTICLE V – SCORING

- (1) Touchdown: 6 points
- (2) PAT (point after touchdown) 1 point (5-yard line) or 2 points (10-yard line)
 - (a). Note: 1 point PAT is pass only; 2 point PAT can be run or pass.
- (3) Safety: 2 points
 - (a) A safety occurs when the ball-carrier is declared down in his/her own end zone. Runners can be called down when their flags are pulled by a defensive player, a flag falls out, they step out of bounds, their knee or arm touches the ground, a fumble occurs in the end zone or if a snapped ball lands in or beyond the end zone.
- (4) Extra points that are returned equals 2 points.
- (5) A team that scores a touchdown must declare whether it wishes to attempt a 1-point conversion (from the 5-yard line) or a 2-point conversion (from the 10-yard line). Any change, once a decision is made to try for the extra point, requires a charged timeout. A decision cannot be changed after a penalty.
- (6) After one team is winning by 28 points or more, in the second half, the game is over. Once a 28 or more point advantage is gained, no PAT will be attempted.
- (7) **Forfeits are scored 28-0 for the winning team.**
- (8) The coaches, officials and scorekeeper must sign the score sheet. If a coach does not sign the score sheet before leaving the field, the scorekeeper will note on that score sheet and the score will be FINAL.

ARTICLE VI – LIVE BALL/ DEAD BALL

- (1) The ball is live at the snap of the ball and remains live until the official whistles the ball dead.
- (2) The official will indicate the neutral zone and line of scrimmage.
 - (a) It is an automatic dead ball foul if any player on defense or offense enters the neutral zone. In regard to the neutral zone, the official may give both teams a “courtesy” neutral zone notification to allow their players to move back behind the line of scrimmage.
- (3) A player who gains possession in the air is considered inbounds as long as one foot comes down in the field of play.
- (4) The defense may not mimic the offensive team signals by trying to confuse the offensive players, while the quarterback is calling out signals to start the play. This will result in an unsportsmanlike conduct penalty.
- (5) Substitutions may be made on any dead ball.
- (6) Any official can whistle the play dead.
- (7) Play is ruled “dead” when:

- (a) The ball hits the ground.
 - (1) If the ball hits the ground as a result of a bad snap, the ball is then placed where the ball hit the ground.
- (b) The ball-carrier's flag is pulled.
- (c) The ball-carrier steps out of bounds.
- (d) A touchdown, PAT or safety is scored.
- (e) The ball-carrier's knee or arm hits the ground.
- (f) The ball-carrier's flag falls out.
- (g) The receiver catches the ball while in possession of one or no flag(s).
- (h) The 7 second pass clock expires.
- (i) Inadvertent whistle.

NOTE: There are no fumbles. The ball becomes a dead ball. (If the ball is fumbled forwards then it will be spotted where the ball carrier lost possession.

- (8) If an inadvertent whistle occurs with no time left on the clock at halftime or end of game, the offense will have one untimed down. The offense has two options:
 - (a) Take the ball where it was when the whistle blew, and the down is consumed.
 - (b) Replay the down from the original line of scrimmage.
- (9) A team is allowed to use a timeout to question an official's rule interpretation. If the official's ruling is correct, the team will be charged a timeout. If the rule is interpreted incorrectly, the timeout will not be charged and the proper ruling will be enforced. Officials should all agree upon any controversial call in order to give each team the full benefit of each call.

VII. Running

1. The ball is spotted where the ball is when the flag is pulled.
2. The quarterback cannot directly run with the ball. The quarterback is the offensive player who receives the snap.
3. Only direct handoffs behind the line of scrimmage are permitted. Handoffs may be in front, behind or to the side of the offensive player but must be behind the line of scrimmage. The offense may use multiple handoffs.
 - a. **"Center sneak" play is no longer allowed. The QB is not allowed to handoff to the center on the first handoff of the play.**
4. Absolutely NO laterals of any kind.
5. No-run Zones are located 5 yards before each end zone and 5 yards on either side of midfield are designed to avoid short-yardage power-running situations. Teams are not allowed to run in these zones if the subsequent line is LIVE. Each offensive team approaches only TWO no-run zones in each drive – one 5 yards from midfield to gain the first down and one 5 yards from the goal line to score a TD).
6. Any player who receives a handoff can throw the ball from behind the line of scrimmage.
7. Once the ball has been handed off in front, behind or to the side of the quarterback, all defensive players are eligible to rush.
8. Runners may not leave their feet to advance the ball. Diving, leaping or jumping to avoid a flag pull is considered flag guarding.
9. Spinning/Jump Cuts are allowed, but players cannot leave their feet to avoid a flag pull.
 - a. Players spinning out of control will be called for flag guarding.
10. Runners may leave their feet if there is a clear indication that he/she has done so to avoid collision with another player without a flag guarding penalty enforced.
11. No blocking or "screening" is allowed at any time.
12. Offensive players without the ball must stop their motion once the ball has crossed the line of scrimmage. No running with the ball-carrier.
13. Flag obstruction – All jerseys MUST be tucked in before play begins. The flags must be on the player's hips and free from obstruction. Deliberately obstructed flags will be considered flag guarding.

VIII. Passing

1. All passes must be from behind the line of scrimmage, thrown forward and received beyond the line scrimmage.
 - a. All passes that do not cross the line of scrimmage, whether received or not, are illegal forward passes.
 - b. The quarterback may throw the ball away to avoid a sack. Pass must go beyond the line of scrimmage.
2. Shovel passes are allowed but must be received beyond the line of scrimmage.
3. The quarterback has a seven-second "pass clock." If a pass is not thrown within the seven seconds, the play is dead, the down is consumed and the ball is returned to the line of scrimmage. Once the ball is handed off, the 7-second rule is no longer in effect.
 - a. If the QB is standing in the end zone at the end of the 7-second clock, the ball is returned to the line of scrimmage (LOS).

IX. Receiving

1. All players are eligible to receive passes (including the quarterback if the ball has been handed off behind the line of scrimmage).
2. Only one player is allowed in motion at a time. All motion must be parallel to the line of scrimmage and no motion is permitted toward the line of scrimmage.
3. A player must have at least one foot inbounds when making a reception.
4. In the case of simultaneous possession by both an offensive and defensive player, possession is awarded to the offense.
5. Interceptions are returnable on conversions after touchdowns (2 points).

X. Rushing the Passer

1. All players who rush the passer must be a minimum of seven yards from the line of scrimmage when the ball is snapped. Any number of players can rush the quarterback. Players not rushing the quarterback can defend on the line of scrimmage.
2. Once the ball is handed off, the seven-yard rule no longer is in effect and all defenders may go behind the line of scrimmage.
3. A special marker, or the referee, will designate a rush line seven yards from the line of scrimmage. Defensive players should verify they are in the correct position with the official on every play.
 - a. A legal rush is:
 1. Any rush from a point 7-yards from the defensive line of scrimmage.
 2. A rush from anywhere on the field AFTER the ball has been handed off by the quarterback.
 - b. A penalty may be called if:
 1. The rusher leaves the rush line before the snap crosses the line of scrimmage before a handoff or pass— illegal rush (5-yards from the line of scrimmage and first down).
 2. Any defensive player crosses the line of scrimmage before the ball is snapped – offsides (5-yards from line of scrimmage and first down).
 3. Any defensive player not lined up at the rush line crosses the line of scrimmage before the ball is passed or handed off – illegal rush (5-yards from the line of scrimmage and first down)
 4. If the offense draws the rusher(s) to jump the seven-yard marker prior to the snap of the ball, that rusher(s) CANNOT rush during that play. However, any other defender that is seven yards back may rush instead. Jumping the rush is not a penalty until the rusher crosses the line of scrimmage prior to the handoff or passed ball.
 - c. Special circumstances:
 1. Teams are not required to rush the quarterback with the seven second clock in effect.
 2. Teams are not required to identify their rusher before the play.
4. Players rushing the quarterback may attempt to block a pass; however, contact to the QB, unless ruled incidental by the official, would result in a roughing the passer penalty.
5. The offense cannot impede the rusher in any way. The rusher has the right to a clear path to the quarterback, regardless of where they line up prior to the snap. If the “path or line” is occupied by a moving offensive player, then it is the offense’s responsibility to avoid the rusher. Any disruption to the rusher’s path and/or contact will result in an impeding the rusher penalty. **If the offensive player does not move after the snap, then it is the rusher’s responsibility to go around the offensive player and to avoid contact.**
6. A sack occurs if the quarterback’s flags are pulled behind the line of scrimmage. The ball will be spotted where possession of the ball is once the flag is pulled.
 - a. A Safety is awarded if the sack takes place in the offensive team’s end zone.

XI. Flag Pulling

1. A legal flag pull takes place when the ball-carrier is in full possession of the ball.
2. Defenders can dive to pull flags but cannot tackle, hold or run through the ball-carrier when pulling flags.
3. It is illegal to attempt to strip or pull the ball from the ball-carrier’s possession at any time.
4. If a player’s flag inadvertently falls off during the play, the player is down immediately upon possession of the ball and the play ends. The ball is placed where the flag lands.
5. A defensive player may not intentionally pull the flags off of a player who is not in possession of the ball.
6. Flag guarding is an attempt by the ball-carrier to obstruct the defender’s access to the flags by stiff arming, dropping the head, hand, arm or shoulder or intentionally covering the flags with the football jersey.

XII. Formations

1. Offenses must have a minimum of one player on the line of scrimmage (the center) and up to four players on the line of scrimmage. The quarterback must be off the line of scrimmage.
 - a. One player at a time may go in motion 1-yard behind and parallel to the line of scrimmage.
 - b. No motion is allowed toward the line of scrimmage.
2. Movement by a player who is set or a player who runs toward the line of scrimmage while in motion is considered a false start.
3. The center must snap the ball with a rapid and continuous motion between his/her legs to a player in the backfield, and the ball must completely leave his/her hands.

XIII. Unsportsmanlike Conduct

1. If the field monitor or referee witnesses any acts of intentional tackling, elbowing, cheap shots, blocking or any unsportsmanlike act, the game will be stopped and the player will be ejected from the game. The decision is made at the referee's discretion. No appeals will be considered. **FOUL PLAY WILL NOT BE TOLERATED!**
2. Offensive or confrontational language is not allowed. Officials have the right to determine offensive language. If offensive or confrontational language occurs, the referee will give one warning. If it continues, the player or players will be ejected from the game.
3. Players may not physically or verbally abuse any opponent, coach or official.
4. Ball-carriers **MUST** make an effort to avoid defenders with an established position.
5. Defenders are not allowed to run through the ball-carrier when pulling flags.
6. Fans must also adhere to good sportsmanship as well:
 - a. Yell to cheer on your players, not to harass officials or other teams.
 - b. Keep comments clean and profanity free.
 - c. Compliment ALL players, not just one child or team.
7. Fans are required to keep fields safe and kids friendly:
 - a. Keep younger kids and equipment such as coolers, chairs and tents a minimum of 10 yards off the field in the end zone area
 - b. Stay in the end zone area, not between fields.
 - c. Dispose of ALL trash in designated trash cans.
8. Unsportsmanlike conduct penalties:
 - a. Defense + 10 yards from line of scrimmage and automatic first down
 - b. Offense - 10 yards from line of scrimmage and loss of down

XIV. Penalties

A. General

1. The referee will call all penalties.
2. Referees determine incidental contact that may result from normal run of play.
3. All penalties will be assessed from the line of scrimmage, except as noted. (Spot fouls)
4. Only the team captain or head coach may ask the referee questions about rule clarification and interpretations. Players may not question calls.
5. Games may not end on a defensive penalty unless the offense declines it.
6. Penalties are assessed live ball then dead ball. Live ball penalties must be assessed before play is considered complete.
7. Penalties will be assessed half the distance to the goal yardage when the penalty yardage is more than half the distance to the goal.
8. In the last 2 minutes of the game offensive offside/false start will result in a **LOSS OF A DOWN**.
 - a. **Defensive penalties**

Offensive pass interference	-5 yards from line of scrimmage and loss of down
Illegal motion (More than one person moving)	-5 yards from line of scrimmage and loss of down
Delay of game	-5 yards from line of scrimmage and loss of down
Impeding the rusher	-5 yards from line of scrimmage and loss of down
Illegal Procedure	-5 yards from line of scrimmage and loss of down

XV. GAMES AND AWARDS

SECTION A - DISTRICT

- (1) Each District shall have the right to conduct its own youth flag football tournament for each age division in a manner approved by the majority vote of participating District Affiliates and provided any exceptions to the rules in this Manual are approved by a District's State Recreational Sports Committee member. District or Affiliate Hosts are responsible for all District awards.
- (2) District level competition in **Youth NFL Flag Football** is to be completed as follows:
 - (a) All divisions must be completed 2 weeks before the state tournament.

SECTION B- STATE

- (1) State tournament will be played the first Saturday in November
- (2) The State Tournament in all divisions of youth flag football shall be divided into pool play. The teams in each pool will play a round-robin schedule. At the end of pool play the top team in the pools will advance to the final games. All teams will be guaranteed a minimum of two games in their pool play.
- (3) Pairings for the State Tournaments will be determined by the State Recreational Sports Committee Chairperson and the Tournament Director.
- (4) Trophies will be awarded to the Affiliates that finish first and second in each division. **A sportsmanship trophy will be awarded in each age division. The Recreational Sports Committee Representatives and the Game Officials will determine the recipients of this award.**

ARTICLE XVI - OFFICIALS AND PARTICIPANTS

SECTION A- HOST

- (1) The Host Affiliate shall provide a Tournament Director as well as "registered" officials or above, in accordance with Rule I, Article IV, Section C, Paragraph 2; Rule II, Article IV, Section B, Paragraph 1(e).
- (2) The Host Affiliate shall be responsible for proper conduct by spectators.
- (3) The Host Affiliate shall be responsible for the game balls in accordance with ARPA specifications in these rules.
- (4) The Host Affiliate shall be responsible for seeing that the playing field requirements meet ARPA specifications.

SECTION B - GAME OFFICIALS

- (1) Either the two- or three-man referee system is permitted.

SECTION C - PLAYERS AND OTHER TEAM MEMBERS

- (1) Any player, coach, manager, team scorer or assistant disqualified for unsportsmanlike conduct, including abusive language is ineligible for further participation in the game in progress and may be dismissed from ARPA competition by a State Recreational Sports Committee Member, Tournament Director, or District Commissioner (at the District level only) subject to appeal by the dismissed person's affiliate.
- (2) The use of ineligible players in accordance with the Rules in the Manual shall result in forfeiture (of game and tournament). Burden of proof rests with the protesting Affiliate representative person. (see Rule II).
- (3) Players who are ejected from any game during ARPA State Competition will not be permitted to play in their teams next scheduled competition.

ARTICLE XVII - PROTESTS AND APPEALS

Protests and appeals are authorized only under the stipulations found in Rule II, Article I, Section A of this Manual.

ARTICLE XVIII. – FEES

- (1) Districts will establish the fee schedule for their District tournaments.
 - (a) In addition to the above fees, there will be a onetime charge of \$10.00 per team to be paid to the State Office. Host will be responsible for collecting.
- (2) Fees from ARPA State Youth Flag Tournaments are to be set at \$150.00.
 - (b) In addition to the above fees, there will be a onetime charge of \$25.00 per team to be paid to the State Office. Host will be responsible for this fee.
